Know all men by these presents: that whereas I, Henry Wick and Wm. E. Thomas hold a joint deed of the following described tract of land situate and lying in the County of Skamania and Territory of Washington, to wit: The (N. E.  $\frac{1}{4}$ ) North East quarter of the North west quarter (N. W.  $\frac{1}{4}$ ) of Sec. six (6) in Township No. One (No. 1) North, of Range six (6) East, containing 40 acres: and also that other parcel of land situated in Skamania Co. known and described as the West half (W  $\frac{1}{2}$ ) of the North East quarter (N. E.  $\frac{1}{4}$ ) and Lots one (1) and Two (2) of section six (6) in said Township No one (1) North of Range six (6) East said tract containing 151 acres, both tracts containing 191 acres, and: Whereas we have agreed upon a division of the above described tracts of land by a line commencing at a point on the North line of Sec. six (6) in the Co. Township and Range above named (20) rods and (17) links west of the North East corner of the North East quarter ( $\frac{1}{4}$ ) of Sec. No. six (6) East, in said Skamania Co. thence: running in a south easterly direction keeping the centre of the Canyon to its mouth and continuing on the same course to the Cascade Road.
