Russell, partners in said firm of Russell, Smith & Co., employed said Robert Manary to perform such labor and render such assistance upon the following terms and conditions, to wit; to labor as foreman in said logging camp for \$100.00 per month; that said Russell, Smith & Co., by said partner last above named, agreed to pay the said Robert Manary for such labor and assistance as hereinbefore set forth; that said contract has been faithfully performed and fully complied with on the part of said Robert Manary who performed labor upon and assisted as foreman in manufacturing said saw logs and in building and operating said logway and logging plant for the period of 6 months; that said labor and assistance were so performed and rendered upon said logs and upon said logging way and upon said logging plant between the 29 day of Jan. 1899, and the 29 day of July 1899, and the rendition of said services was closed on the 29 day of July 1899, and 30 days have not elapsed since that time; that the amount of claimant's demand for said services is \$600.00 dollars; that no part thereof has been paid except \$45.57 dollars, and there is now due and remaining unpaid thereon, after deducting all just credits and offset the sum of \$554.43 dollars, in which amount he claims a lien upon said logs and upon said personal property and said real property hereinbefore described; that said Robert Manary also claims a lien on all said logs, franchises, earnings, contracts, logging road and all personal property and upon all real property now owned by said J. C. Russell, B. D. Russell, W. J. Smith, and J. H. Parclius as partners under the firm name of Russell, Smith & Co. in said Skamania County, Washington, to receive payment for the work and labor performed as herein described.
