Notice is hereby given that Hugh Sawyer, of Skamania County State of Washington claims a lien upon about 500 cords of shingle bolts which were cut or manufactured in Skamania County State of Washington and are now lying on the following described land about 350 cords on NW 1/4 Sec 26 belonging to Geo. A. Somonds and about 150 cords on NW 1/2 S. W. 1/4 Sec 23 E. 1/2 S. E. 1/4 Section 22 belonging to Chas. Myers all of T. 4 N. 9 E. W. M. Skamania County Washington for labor performed upon and assistance rendered in cutting and making said shingle bolts; that the owner of the same or reputed owner is J. E. Segor, R. D. Jones or Skamania Lumber Co, the he employed Hugh Sawyer to perform such labor and render such assistance upon the following terms and conditions, to-wit:

The said R. D. Jones agreed to pay the said Hugh Sawyer 80 cents per cord for the cutting and making said bolts; that the contract has been faithfully performed and fully complied with on the part of said Hugh Sawyer; that the labor performed in cutting and making said shingle bolts, was rendered between the 1st day of Feb 1898 and the 5th day of April 1898, and the rendition of said service was closed on the 5th day of April 1898 and thirty days have not elapsed since that time; that the amount of Claimants demand for said service is \$103.80; that no part thereof has been paid except — and there is now due and remaining unpaid thereon after deducting all just credits and offsets the sum of \$103.80, in which he claims a lien upon the said shingle bolts
