M. McKinnon vs C. Wilson & others

Notice is hereby given that Mr McKinnon claims a
lien upon the franchise, earnings and all the real and
personal property of Wilson, Gropper & Co, the same being a
company engaged in the operation of a sawmilling, lumber
and timber business in Skamania County, State of Washing-
ton, said company being composed of C. Wilson, Casper
Gropper and P. J. Bannon, who are engaged in conducting
said business, and in the operation of the said sawmilling,
lumber and timber business under the firm name and style
of Wilson, Gropper & Co.

That the said property of the said company upon which
this claimant claims a lien is as follows, to-wit:-

Upon a certain wooden building..... by..... feet
in size situated upon the North East quarter of Section 35,
Township 3, North of Range 7, East of the Willamette Meri-
dian, in Skamania County, State of Washington, used
as a sawmill building by the said company.

Also upon the steam boiler and engines, sawmill
machinery, pulleys, belting, shafts, saws, chains, tools, and
any and all machinery or tools connected with or in any
manner used in and about the said sawmill and sawmill
building so situated as aforesaid

Also upon 150 fir sawlogs now lying in Port Creek

Take in said Skamania County, State of Washington, near the said sawmill, the same being about 100,000 feet in quantity, and the property of the said company and upon the land hereinbefore described;

Also upon 100,000 feet of sawed lumber belonging to said company a part thereof now being at the dock on the north bank of the Columbia river at Stevenson, Washington, and a part on a scow attached to said dock, at said town of Stevenson said scow, being known as the Maine and being in charge of one C. Poley, Master.

Also upon one wooden flume, running from a connection with a certain ditch leading from said mill at a point in.... Section 1 Township 3 North Range 7 E. W. in said County, to the Columbia river: together with the franchise upon which the said flume is constructed and operated.

This claim is claimed for labor performed by the claimant for the said company in the operation of said sawmilling, lumber and timber business in Skamania County, State of Washington, upon the following terms and conditions to wit:-

That the claimant was employed to perform said labor and to render said services for the said company by Casper Gropper who was at the date of the employment of this claimant to perform said labor and render said services, one of the members of said copartnership.

That claimant commenced to perform said services on the 1st day of August 1899, and ceased the performance thereof on the 16th day of September 1899 the last services being performed by him for said company the last date mentioned herein, performing between said dates 15 days labor for said company under the terms and conditions as heretofore stated.

That there became due the claimant for the performance of said services, in accordance with the terms of said contract, the sum of \$34.00 That there has been paid thereon the sum of \$..... and no more

That there is now due the claimant after deducting all just credits and offsets from the said company the sum of \$39.⁵⁰ in which sum claimant claims a lien upon the property of the said company hereinbefore fully described.
