TO ALL TO WHOM THESE PRESENTS SHALL COME, GREETING:

909 Certificate No. 2431 WHEREAS Millard F. Bennett of Skamania County, Washington Territory has deposited in the General Land Office of the United States a Certificate of the Register of the Land Office at Vancouver, Washington Territory whereby it appears that full payment has been made by the said Millard F. Bennett according to the provisions of the Act of Congress of the 24th of April, 1820, entitled "An Act making further provision for the sale of the Public lands," and the acts supplemental thereto, for the south west quarter ~~of~~ or the east half of the southwest quarter and the lots numbered three and four of section eighteen in township three north of range ten east of Willamette Meridian in Washington Territory containing one hundred and sixty one acres and forty hundredths of an acre, according to the official plat of the Survey of the said lands returned to the General Land Office by the Surveyor General which said tract has been purchased by the said Millard F. Bennett

NOW KNOW YE, That the United States of America, in consideration of the premises, and in conformity with the several Acts of Congress in such case made and provided, have given and granted, and by these presents do give and grant unto the said Millard F. Bennett and to his heirs, the said Tract above described. To Have and to Hold the same, together with all the rights, privileges, immunities, and appurtenances of whatsoever nature, thereunto belonging unto the said Millard F. Bennett and to his heirs and assigns forever; subject to any vested and accrued water rights for mining, agricultural, manufacturing, or other purposes, and rights to ditches and reservoirs used in connection with such water rights as may be recognized and acknowledged by the local customs, laws and decisions of courts, and also subject to the right of the proprietor of a vein or lode to extract and remove his ore therefrom, should the same be found to penetrate or intersect the premises herein granted, as provided by law.

IN TESTIMONY WHEREOF I, Benjamin Harrison, President of the United States of America have caused these letters to be made Patent and the Seal of the General Land Office to be hereunto affixed.
