## SCHEDULE "A"

COLUMBIA VISTA CORPORATION

to

Skamania County, Washington

A right of way for the Skamania County Road known and designated Old State Road (3), Cor. Road No. 21480 being that portion of the South 13.30 chains of Government Lot 5, Section 6, Township 3 North, Range 8 E.W.M. lying southerly and westerly of a line drawn parallel to and 30 feet distant left from the following described centerline.

Beginning at the County monument marking the West one quarter corner of Section 6, Township 3 North, Range 3 E.W.M.; thence N 0° 44' 24" E along the West line of said Section 6, 879.13 feet; thence East 7.37 feet to an iron bar marking the centerline of the County Road and being the point of beginning; thence S 1° 27' 21" W, 710.82 ft. to the P.C. of a 167 foot radius curve to the left; thence following said curve to the left 264.99 feet; thence S 89° 27' 29" E 464.61 feet to the P.C. of a 231 foot radius curve to the right; thence following said curve to the right 239.48 feet.

Excepting that portion of the above described Right of Way lying southerly of a tract of land deeded to Chester Latimer and Myrnie Latimer by deed dated July 15, 1971 and recorded July 23, 1971 at Page 63 of Book 124 of Deeds, Records of Skamania County, Washington

And also excepting that portion of the above described Right of Way lying southerly of that tract of land conveyed to the public for use as a public burying place by deed dated May 3, 1901 and recorded May 4, 1901 at page 300 of Book G of Deeds, Records of Skamania County, Washington.

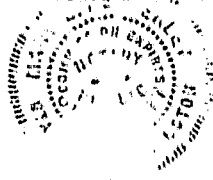
