## EASEMENT

The Grantor, SKAMANIA COUNTY, a municipal corporation of the State of Washington, for and in consideration of Cne Dollar (\$1.00) and other valuable consideration, grants and conveys to the State of Washington, acting by and through its Department of Natural Resources, Grantee, its successors and assigns s permanent easement over and across the following described lands in Skamania County, Washington, to wit:

Upon, over, and along rights of way sixty (60) feet in width over and across the SWANNA of Section 10, Township 2 North, Range 7 East, W. M., being thirty (30) feet on each side of the centerline(s) of a road or roads located app oximately as shown in red on the attached Exhibit A.

SUBJECT AS TO SAID LANDS TO ALL MATTERS OF FUBLIC RECORD.

The easement granted herein is subject to the following terms and conditions:

- The road to be constructed and/or maintained on the said right of way shall be used for access to lands presently or in the future owned or controlled by the Grantee for lend management and administration activities, including but not limited to valuable material removal operations, and for public access to such lands for recreational purposes under such rules, regulations, and limitations as may be established by Grantee.
- The Grantor reserves to itself, its successors and assigns, the right to use, at its own risk, the roadway in any manner which does not unreasonably interfere with the use of said road by the Grantee, its successors and assigns, agents, contractors, employees, lessees, or licensees, or the public when on said road in conformity with the rules, regulations, and limitations referred to in Condition I above. Said road users will, except the public, contribute their pro rata share to the maintenance costs caused by their usage so that such maintenance will leave the road in as good condition as it existed at the time of commencement of said use.


