

LEGAL DESCRIPTION

ENTIRE CONTIGUOUS OWNERSHIP

THAT PORTION OF THE EAST HALF OF THE NORTHEAST QUARTER OF THE SOUTH-WEST QUARTER OF SECTION 21, TOWNSHIP 3 NORTH, RANGE 10 EAST, WILLAMETTE MERIDIAN, LYING SOUTHERLY OF THE COUNTY ROAD KNOWN AND DESIGNATED AS THE UNDERWOOD-WILLARD HIGHWAY;

EXCEPT THE FOLLOWING DESCRIBED TRACT; BEGINNING AT A POINT ON THE EAST LINE OF THE EAST HALF OF THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SAID SECTION 21 WHICH IS 20 FEET SOUTH AND 15 FEET WEST OF THE INTERSECTION OF THE COUNTY ROAD KNOWN AND DESIGNATED AS THE KRAMER ROAD AND THE SAID UNDERWOOD-WILLARD HIGHWAY; THENCE FOLLOWING THE SOUTHERLY LINE OF SAID U-W HIGHWAY SOUTH 50° 53' WEST 355.3 FEET; THENCE SOUTH 30° 12' EAST 556.3 FEET TO THE INTERSECTION WITH THE EAST LINE OF THE EAST HALF OF THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SAID SECTION 21; THENCE NORTH 701.2 FEET TO THE POINT OF BEGINNING;

EXCEPT THE FOLLOWING DESCRIBED TRACT: BEGINNING AT A POINT ON THE SOUTHERLY LINE OF THE SAID UNDERWOOD-WILLARD HIGHWAY, SAID POINT BEING 1801.1 FEET SOUTH AND 179.7 FEET EAST OF A RAILROAD IRON MARKING THE SOUTHWEST CORNER OF THE EAST HALF OF THE NORTHEAST QUARTER OF THE NORTHWEST QUARTER OF SAID SECTION 21; THENCE 839 FEET, MORE OR LESS TO THE SOUTH LINE OF THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SAID SECTION 21; THENCE WEST ALONG SAID SOUTH LINE 180 FEET MORE OR LESS, TO THE SOUTHWEST CORNER OF THE EASH HALF OF THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SAID SECTION 21; TOGETHER WITH A TRACT FOR USE AS A ROAD AND ACCESS TO ABOVE PROPERTY BEGINNING AT THE WESTERLY CORNER OF THE TRACT OF LAND FIRST ABOVE EXCEPTED; THENCE SOUTH 30° 12' EAST 21 FEET; THENCE NORTH 27° 57' EAST 52.3 FEET; THENCE SOUTH 50° 53' WEST 45 FEET TO THE POINT OF BEGINNING.



M.; THENCE NORTH 839 FEET, MORE OR LESS, TO A STONE MONUMENT LYING ON THE SOUTHERLY MARGIN OF COUNTY ROAD KNOWN AND DESIGNATED AS THE UNDERWOOD-WILLARD HIGHWAY, SAID POINT BEING 179.7 FEET EAST AND 1801.1 FEET SOUTH OF THE SOUTHWEST CORNER OF THE EAST HALF OF THE NORTHEAST QUARTER OF THE NORTHWEST QUARTER OF SAID SECTION 21; THENCE SOUTH 30° EAST 945 FEET, MORE OR LESS, TO THE SOUTH LINE OF THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SAID SECTION 21; THENCE WESTERLY ALONG THE SOUTH LINE OF THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SAID SECTION 21 TO POINT OF BEGINNING; TOGETHER WITH AND INCLUDING AN EASEMENT FOR ROAD USE AND ACCESS TO SAID LOT 1 BEGINNING AT SAID STONE MONUMENT; THENCE EASTERLY ALONG THE SOUTHERN BOUNDARY OF SAID UNDERWOOD-WILLARD HIGHWAY FOR A DISTANCE OF 30 FEET; THENCE SOUTH 30° WEST 50 FEET, MORE OR LESS, TO THE JUNCTION OF THE EAST LINE OF THE ABOVE DESCRIBED PARCEL, THENCE NORTH 30° WEST ALONG SAID EAST LINE OF SAID DESCRIBED PARCEL TO POINT OF BEGINNING.
