REAL ESTATE CONTRACT

Any existing contract a contract under which seller is purchasing said real estate, and thry mortgage or other abliga-tion, which soller by this contract agrees to pay, none of which for the purpose of this paragraph (5) shall be deemed defects in seller's title.

(6) If seller's title to said real estate is subject to an existing contract or contracts under which seller is purchasing said teal estate, or any martgage, deed of trust or other obligation which seller is pay, seller agrees to make such payments in accordance with the terms thereof, and upon default, the purchaser shall have the right to make any payments necessary to remove the default, and any payments so made shall be applied to the payments next falling due the seller under this contract.

(7) The seller agrees, upon receiving full payment of the purchase price and interest in this manner above specified, to assecute and deliver to purchaser a statutory warranty <u>EulEillment</u> deed to daid real estate, excepting any port thereof hereafter taken for public use, free of encumbrances except any that may attach after date of closing through any person other than the seller, and subject to the following:

Easements and rights of way for County Roads No. 2028 and 2337 designated as the Loop Road and the Cloverdale-Skaar Road.

(8) Unless a different date is provided for herein, the purchaser shall be entitled to possession of said real estate on date of closing and to retain possession so long as purchaser is not in default hereinder. The purchaser doverants to keep the buildings ong other improvements on said real estate in good repair and not to permit waste and not to use, or permit the use of, the real estate for any illegal purpose. The purchaser covariants to pay all strivice, installation or construction charges for water, sewer, electricity, garbage or other utility services furnished to said real estate after the date purchaser is entitled to possession.

(9) In case the purchaser fails to make any payment herein provided or to maintain insurance, as herein required, the seller may make such payment or effect such insurance, and any amounts so pold by the seller, together with interest at the rate of 10% per annum thereon from date of payment until repaid, shall be repayable by purchaser on seller's demand, all without prejudice to any other right the sellor might have by reason of such default.

(10) Time is of the essence of this contract, and if is agreed that in case the purchaser shall fail to comply with an perfarm any condition or agreement hereof or to make any payment required hereunder promptly at the time gird in the manner herein required, the seller may elect to declare all the purchaser's rights hereunder terminated, and upon his doing so, all payments made by the purchaser hereunder and all improvements placed upon the real estate shall be torteited to the seller as liquidated domages, and the seller shall have right to re-enter and take possession of the real estate, and no waiver by the seller of any default on the part of the purchaser shall be construed as a waiver of any subsequent default.
