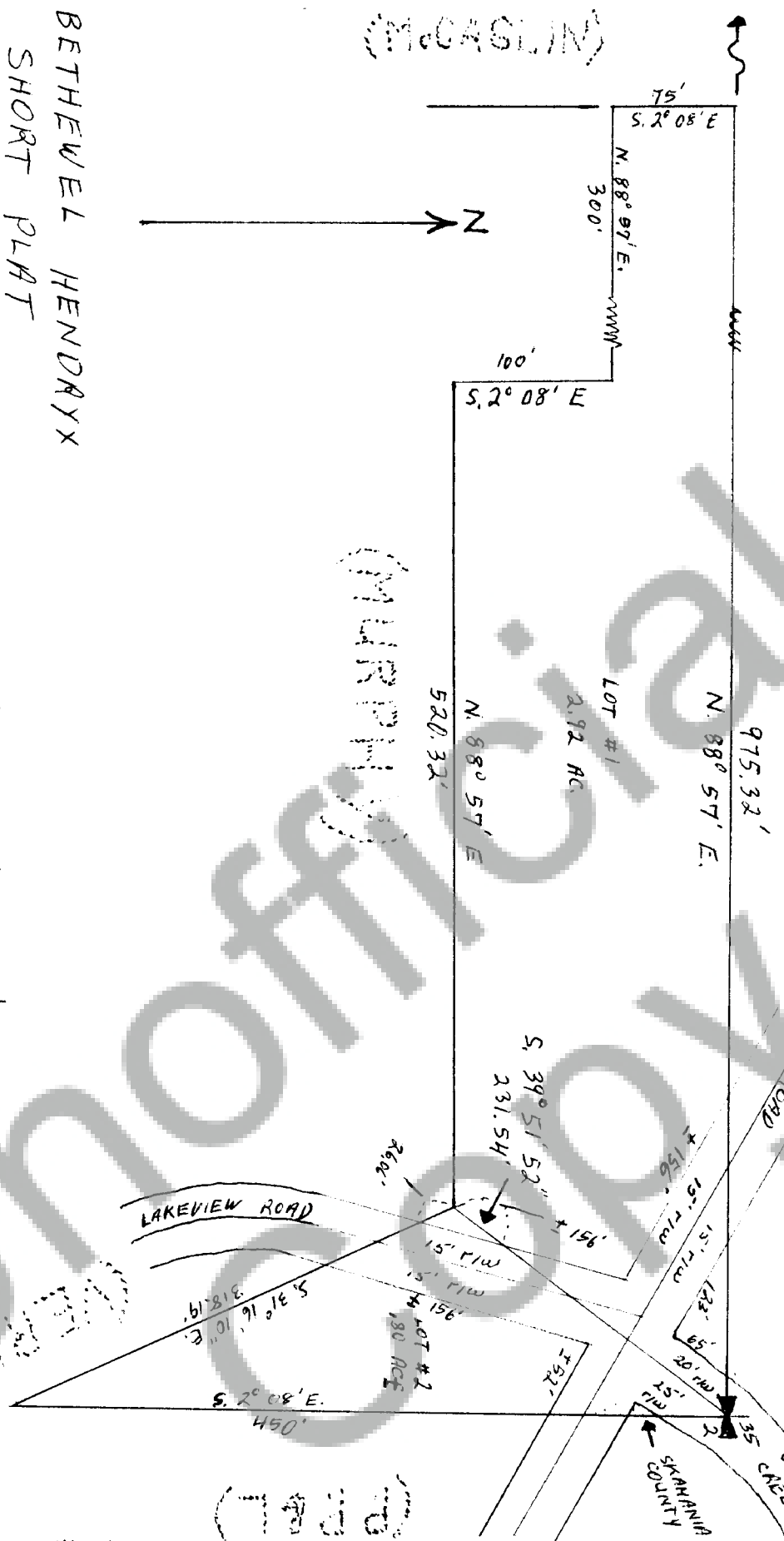
BETHEWEEL HENDRYX
