 together with all after acquired title of the grantor(s) therein:

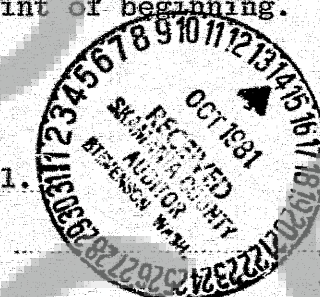
A tract of land in Section 27, Township 2 North, Range 6 E.W.M., described
