A parcel of land located in the southeast quarter of the southwest quarter S.E. 1/4, S.W. 1/4 of Section 24, Township 3 North, Range 7 East W.M. in Skamania County, Washington. More particularly:

Centerline Description

Beginning at Station 0+00, said point lying S 31° 58' 06" W 6.98 feet from the iron rod marking the south quarter corner of Section 24, Township 3 North, Range 7 East W.M.; thence N 88° 47' 54" W 393.30 feet to P.C. Station 3+93.30 being the P.C. of a 150 foot radius curve to the right; thence following said curve through a central angle of 61° 30' 51" 161.09 feet; thence N 27° 16' 03" W 94.60 feet to P.C. Station 6+55.87, being the P.C. of a 150 foot radius curve to the left; thence following said curve through a central angle of 95° 05' 19" 248.94 feet; thence S 57° 38' 38" W 18.60 feet to P.C. Station 9+23.41, being the P.C. of a 250 foot radius curve to the right; thence following said curve through a central angle of 43° 51' 08" 191.34 feet; thence N 78° 30' 14" W 206.44 feet to P.C. Station 13+21.19, being the P.C. of a 150 foot radius curve to the right; thence following said curve through a central angle of 74° 34' 56" 195.26 feet; the P.T. Station 15+16.44, said point lying N 77° 19' 21" E 1395.56 feet from the southwest corner of said Section 24.

Parcel Description

That portion of the following described parcel lying within that real property described in deed to Samuel P. & Carrie Ann White, dated 20 March, 1980, and recorded at Page 280, Book 78 of Deed, Records of Skamania County.

A strip of land located in that portion of the west half of the southeast quarter of the southwest quarter (W 1/2, S.E. 1/4, S.W. 1/4) of Section 24, Township 3 North, Range 7 East W.M. lying northerly of the above described centerline and southerly of a line drawn as follows:

Parallel to and 40 feet distant from Engineer's Station 8+50 to Station 9+00; thence to a point 35 feet distant right from Station 9+50; thence parallel to and 35 feet distant right of said centerline from Station 9+50 to Station 10+50; thence to a point 30 feet distant right from Station 11+00; thence parallel to and 30 feet distant right from Station 11+00 to Station 16+00.
