THIS SUPPLEMENTAL AGREEMENT, made and entered into this 17th day of November 19 81 , by and hetween LONGVIEW FIGRE COMPANY, a Delaware corporation, herein called "Longview Fibre," and STATE OF WASHINGTON, acting by and through the Department of Natural Resources, herein called "State," WITNESSETH:

Whereas, on the 14th day of December, 1978, Longview Fibre and the State entered into an easement exchange hereinafter calle Original Easement, which was recorded in the records of Cowlitz County, Washington, on the 29th day of January, 1979, in Volume 878 of Deeds, pages 132-137 under Auditor's File No. 848753, and in the records of Skamania County, Washington, on the 16th day of January, 1979, in Volume 76 of Deeds, pages 18-23 under Auditor's File No. 87913. Said Original Easement is hereby supplemented as follows:

A. Longview Fibre for and in consideration of Four Thousand Six Hundred Sixty-Four and No/100 Dollars (\$4,664.00) and the grant hereinafter made by the State, hereby grants and conveys to State, its successors and assigns, a permanent easement upon, over, and along rights of way sixty (60) feet in width, over and across the SW1/4NW1/4, Section 15, Township 2 North, Range 5 East, W.M., in Skamania County, Washington, being thirty (30) feet on each side of the centerline of a road or roads located approximately as shown in red on the attached "Exhibit A."

Subject as to said lands to all matters of public record,

B. State, for and in consideration of the grant hereinabove made, hereby grants and conveys to Longview Fibre, its successors and assigns, a permanent easement upon, over, and along rights of wry sixty (60) feet in width over and across the NW1/4SW1/4, Section 15 and the NE1/4SE1/4, Section 16, Township 2 North, Range 5 East, W.M., in Skamania County, Washington, being thirty (30) feet on each side of the centerline of a road or roads located approximately as shown in green on the attached "Exhibit A."

Subject as to said lands to all matters of public record.

C. Provided, however, thirty (30) days prior to any reconstruction, and/or betterment of said road(s) by either party on lands of the other party, the initiating party will submit to the landowning party a written request for joint review of the proposed project, upon completion of which the initiating party will submit a complete and detailed plan of operations. Each parties' operations, specified herein shall be conducted in accordance with the provisions of the approved plan of operations. Said parties shall provide the other party the right of examination of the right of way before any construction, reconstruction, or development is commenced.

Except as herein supplemented all of the terms, conditions and reservations of the Original Easement shall remain in full force and effect.


