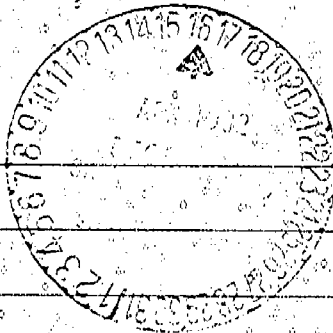

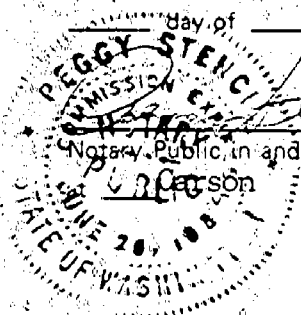

A tract of land located in Section 27, Township 3 North, Range 8 E. W. M., described as follows:

Beginning at the intersection of the easterly line of the William M. Murphy D. L. C. with the northerly right of way line of Primary State Highway No. 8 as it existed in 1962, said point being marked by a bronze monument 578.09 feet northerly from the intersection of the easterly line of said William M. Murphy D. L. C. with the south line of said Section 27; thence along the northerly right of way line of Primary State Highway No. 8 as follows: North $66^{\circ} 34'$ west 230.5 feet; thence north $23^{\circ} 26'$ east 20 feet; thence north $66^{\circ} 34'$ west 250 feet; thence south $23^{\circ} 26'$ west 10 feet; thence north $66^{\circ} 34'$ west 416 feet to the initial point of the tract hereby described; thence along the northerly right of way line of said highway north $66^{\circ} 34'$ west 134 feet; thence north $23^{\circ} 26'$ east 80 feet to a concrete post; thence north $66^{\circ} 34'$ west 184.8 feet; thence south $23^{\circ} 26'$ west 30 feet; thence north $66^{\circ} 34'$ west 15.2 feet to intersection with the southeasterly right of way line of the county road known and designated as the House Road; thence following the southeasterly right of way line of said county road northerly and easterly to a point north $23^{\circ} 26'$ east 215.6 feet from the initial point; thence south $23^{\circ} 26'$ west 215.6 feet to the initial point;

TOGETHER WITH the existing water pump installation and an easement for a 3/4 inch water pipeline to be used for domestic purposes and the right to repair and maintain the same;

AND SUBJECT TO relinquishment of rights of access to Primary State Highway No. 8 as more particularly set forth in deed to the State of Washington dated January 24, 1955, and recorded February 18, 1955, at page 226 of Book 39 of Deeds, under Auditor's File No. 48265, Records of Skamania County, Washington.
