EASEMENT SUPPLEMENT

THIS SUPPLEMENTAL AGREEMENT, made and entered into this 14th day of April, 1982, by and between CROWN ZELLERBACH CORPORATION, a Nevada corporation, herein called "Crown," successor in interest to ELIZABETH BOND STARKER, and STATE OF WASHINGTON, acting by and through the Department of Natural Resources, herein called "State," WITNESSETH:

Whereas, on the 3rd day of January, 1977, Starker and the State entered into an easement exchange hereinafter called Original Easement, which was recorded in the records of Skamania County, Washington, on the 25th day of January, 1977, in Volume 72 of Deeds, page 185 under Auditor's File No. 83497. Said Original Easement is hereby supplemented as follows:

A. Crown for and in consideration of One Dollar (\$1.00) and other valuable consideration hereby grants and conveys to State, its successors and assigns, a permanent easement upon, over, and along rights of way sixty (60) feet in width, over and across the SW1/4NE1/4, SE1/4NW1/4, NE1/4SW1/4, Section 16, Township 2 North, Range 7 East, W.M., in Skamania County, Washington, being thirty (30) feet on each side of the centerline of a road or roads located approximately as shown in red on the attached "Exhibit A." Subject as to said lands to all matters of public record.

B. Provided, however, thirty (30) days prior to any reconstruction, or development, the State shall submit to Crown for written approval, a complete and detailed plan of operation for the development of the right of way. The State's operations specified hereinabove shall be conducted in accordance with the provisions of the approved Plan of Operation in force at the time of the commencement of said operations and the State shall provide for the examination of the right of way with Crown's representative, before any construction, reconstruction, or development is commenced.

Except as herein supplemented all of the terms, conditions and reservations of the Original Easement shall remain in full force and effect.

IN WITNESS WHEREOF, the parties hereto have executed this instrument, in duplicate, to become effective as of the day and year first above written.

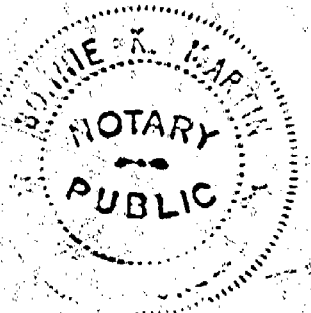
