Lots 20, 21 and 22 of Block One of BOYD & WILKINSON'S ADDITION TO CARSON, according to the official plat thereof on file and of record at Page 36 of Book "A" of Plats, records of Skamania County, Washington.

Grantors are the sole owners of all rights, title and interests in and to The Mathias Corporation, an inchoate corporation of the State of Washington. Proceedings were commenced to form The Mathias Corporation but such proceedings were abandoned prior to the filing of Articles of Incorporation and the issuance of a Certificate of Incorporation. No stock was ever issued by The Mathias Corporation. The named Grantees were the only contemplated shareholders of said inchoate corporation.

The purpose and intent of this deed is to convey to the Grantee all right, title and interest of the named Grantors and of The Mathias Corporation for the purpose of clearing Grantee's title of any claims of the named Grantors or of The Mathias Corporation.
