CONSENT AGREEMENT

WHEREAS, Northwest Pipeline Corporation, a Delaware Corporation, hereinafter called the "CONSENTER", has an interest in the real property herein- after described by virtue of a prior easement dated the 12th day of May 19 77, and recorded the 1st day of August 19 77, in Book 73, Page 153, Deed Records of Skamania County, State of Washington, and which easement traverses the following described real property, situated in the County of Skamania State of Washington, to wit:

WHEREAS, Crown Zellerbach, a Nevada Corporation, hereinafter called the "GRANTOR", has conveyed to the United States of America, hereinafter called the "GRANTEE", an easement for right-of-way purposes over and across said real property by virtue of instrument dated the 8th day of June 19 82, in Lots 1, 2, 3, 4 Section 9 and NW $\frac{1}{4}$ NW $\frac{1}{4}$ Section 16, T2N, R7E, W.M.,

NOW, THEREFORE, the Consenter consents to the above mentioned conveyance from the grantor to the grantee upon the real property hereinbefore described. This Consent is subject to the terms and conditions set forth in the Addendum hereto.

ADDENDUM TO
CONSENT AGREEMENT

The foregoing Consent Agreement is entered into by Northwest Pipeline Corporation subject to the following terms and conditions:

1. Northwest Pipeline Corporation operates and maintains a high pressure natural gas transmission line upon the easement identified in the Consent Agreement and reserves the right, which the United States of America acknowledges, to maintain and repair its facilities and to maintain its easement, and in so doing may from time to time interrupt normal usage of the easement granted to the United States of America by Crown Zellerbach.

2. By acceptance of this Consent Agreement, the United States of America waives all claims for damages by reason of interruption of usage of its easement occasioned by the above-described maintenance and repair activities of Northwest Pipeline Corporation, and agrees to save harmless Northwest Pipeline Corporation from claims of other users or prospective users of its easement when such claims are based upon interruption or prevention of use by reason of Northwest Pipeline Corporation's maintenance and repair activities.

3. Northwest Pipeline Corporation may construct a second natural gas pipeline approximately parallel to its existing pipeline upon its present easement, or a second easement in close proximity to its present easement. Should Northwest Pipeline Corporation construct such a line, the United States of America will give its consent to such construction and the maintenance of the pipeline across the easement of the United States of America described in this Consent Agreement.
