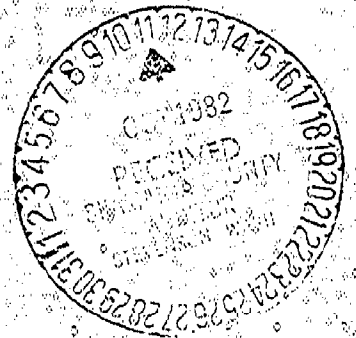

Parcel "A"

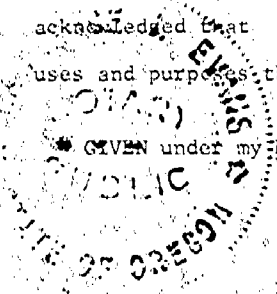
