

ADDENDUM TO REAL ESTATE CONTRACT

NOW, THEREFORE, the parties agree that the legal description set out in the second paragraph on page 1 of the aforementioned Real Estate Contract is hereby amended to read:

The South Half of the Southeast Quarter of the Southwest Quarter of the Northwest Quarter of Section 35, Township 4 North, Range 7 East of the Willamette Meridian, located in Skamania County, Washington...;

AND, EXCEPT AS HEREIN MODIFIED, said Real Estate Contract is affirmed in its' entirety.
