

EASEMENT

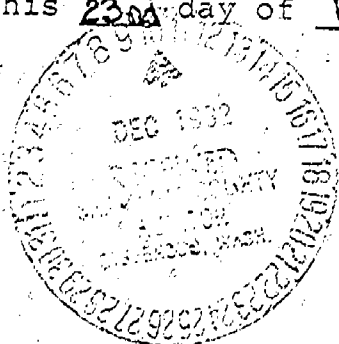
FOR A VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, the Grantors, DANNIE G. TRUELOVE and CYNTHIA D. TRUELOVE, husband and wife, hereby grant and convey to the Grantee, SKAMANIA COUNTY FIRE DISTRICT NO. 5, a municipal corporation, its successors and assigns, the right, privilege and authority to construct, improve, repair and maintain an easement 20 feet in width over and across the northerly 20 feet of the following described real property for roadway purposes, to-wit:

Beginning at the Northeast corner of the Southwest Quarter of the Northeast Quarter (SW4NE4) of Section 34, Township 2 North, Range 6 E.W.M.; thence South on subdivision line 660 feet; thence west 288 feet to the initial point of the tract hereby described; thence west 22 feet, more or less, to the county road known as Skelton Cut-Off Road; thence southerly along said Skelton Cut-Off Road to intersection thereof with the northerly line of Primary State Highway No. 8; thence easterly along the northerly line of Primary State Highway No. 8 a distance of 280 feet; thence in a straight line in a northerly direction 406 feet to the initial point.

The Grantee shall make no use of the easement conveyed herein except for the purposes of ingress and egress over and across said property; that in exercising the rights herein granted, Grantee, its' successors and assigns, may pass and repass over said property, may cut and remove brush, trees, and other obstructions which, in the opinion of the Grantee, interfere with the construction and maintenance of said roadway.

The covenants herein contained shall run with the land and are binding upon all subsequent owners hereof.

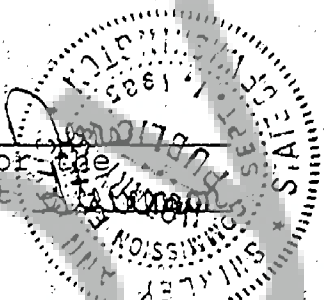
