

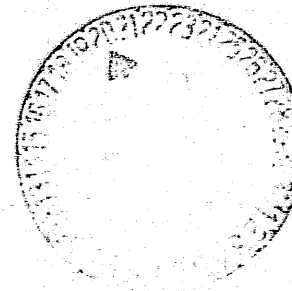

NOTICE TO ALL PROPERTY OWNERS, LESSEES,
SUBLESSEES, ASSIGNEES AND USERS OF WATER
EMINATING FROM THE NORTH WOODS RECREATION
AREA, AND AS OTHERWISE ADMINISTERED BY THE
NORTH WOODS ASSOCIATION, LOCATED IN:

Section 26, Township 7,
North, Range 6 East,
Willamette Meridian, in
Skamania County, Washington.

BE IT ALL KNOWN that any privileges or rights to water, be it as a result of agreement, lease, sublease, or otherwise, directly from the State of Washington, the Department of Natural Resources, Water Front Recreation, Inc., Robert Curry, Lessees or Sublessees of said named individuals or entities, or through other parties and entities not otherwise listed, including The North Woods Association, shall be subject to water use and related charges, and such restrictions and limitations on the use of such water as may take place pursuant to the decision of The North Woods Association Board of Directors.

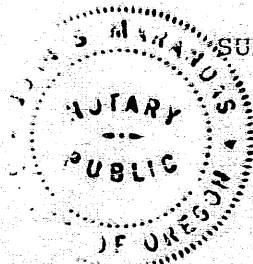
Notice is further given that water privileges may be suspended as may be otherwise provided by law, and that no use of water shall be otherwise allowed except for residential purposes and only such other purposes as the Board of Directors of The North Woods Association has or will allow. Any past granting of water usage shall not constitute a waiver of the future right to terminate or limit use of water, whether or not as a result of a lack of water due to dry periods. Any person or entity using or benefiting by the use or availability of water shall be subject to assessment as set forth by the Board of Directors of The North Woods Association.

Notice is also given that any successors in interest to any property or interests in land, or successors in interest to the use of any water shall be subject to restriction as herein set forth, and that all purchasers, transferees, and assignees of any rights or privileges within the jurisdiction of The North Woods Association shall take subject to these restrictions and conditions.
