EASEMENT SUPPLEMENT

THIS SUPPLEMENTAL AGREEMENT, made and entered into this 1-7th day of 19 828, by and between BROUGHTON LUMBER CO., a Washington corporation, Kerein called "Broughton," and STATE OF WASHINGTON, acting by and through the Department of Natural Resources, herein called "State," WITNESSETH:

Whereas, on the 5th day of November, 1979, Broughton and the State entered into an easement exchange hereinafter called Original Easement, which was recorded in the records of Skamania County, Washington, on the 26th day of December, 1979, in Volume 77 of Deeds, pages 728-732 under Auditor's File No. 90122. Said Original Easement is hereby supplemented as follows:

A. Broughton for and in consideration of One Hundred Twenty and No/100 Dollars (\$120.00) for land damages hereby grants and conveys to State, its successors and assigns, a permanent easement upon, over, and along rights of way sixty (60) feet in width, over and across portions of the NW1/4SE1/4SE1/4, Section 25, Township 4 North, Range 9 East, W.M., in Skamania County, Washington, being thirty (30) feet on each side of the centerline of a road or roads located approximately as shown in red on the attached "Exhibit A."

Subject as to said lands to all matters of public record.

B. Provided, however, thirty (30) days prior to any construction, reconstruction, or development, the State shall submit to the Area Manager at Broughton, Washington, for written approval, a complete and detailed plan of operation for the development of the right of way. The State's operations specified hereinabove shall be conducted in accordance with the provisions of the approved Plan of Operation in force at the time of the commencement of said operations and the State shall provide for the examination of the right of way with Broughton's representative, before any construction, reconstruction, or development is commenced.

Except as herein supplemented all of the terms, conditions and reservations of the Original Easement shall remain in full force and effect.
