A right-of-way as required for the county road known and designated Cook-Underwood Road, County Road No. 93041, located in the northeast quarter (N.E. 1/4) of Section 23, and the southwest quarter (S.W. 1/4) of Section 14, Township 3 North, Range 9 East W.M. in Skamania County, Washington.

Parcel 1Centerline Description

Beginning at the U. S. Government brass monument marking the south quarter corner of Section 23, Township 3 North, Range 9 East W.M.; thence N 18° 36' 22" E along the west line of the east half of said Section 23, 3002.17 ft.; thence east 308.28 feet to Engineer's Sta. 136+30 being the initial point of the centerline herein described, thence N 12° 05' 26" W 153.75 ft. to P.C. Station 137+83.75, being the P.C. of a 1000 foot radius curve to the left; thence following said curve to the left through a central angle of 3° 0' 28" 52.49 feet. Thence N 15° 05' 54" W 632.85 ft. to P.C. Station 144+69.09, being the P.C. of a 350 foot radius curve to the right; thence following said curve to the right through a central angle of 24° 53' 59" 152.10 feet. Thence N 9° 48' 4" E 34.03 ft. to P.C. Station 146+55.23, being the P.C. of a 500 foot radius curve to the left; thence following said curve to the left through a central angle of 28° 52' 07" 251.92 ft.; thence N 9° 04' 03" W 120.80 ft. to P.O.T. Sta. 150+27.95, said station being a point on the west line of the N.E. 1/4 of said Section 23, 962.23 ft. south of the north quarter corner of Section 23, Township 3 North, Range 9 East W.M.; thence N 19° 04' 03" W 122.05 ft. to Sta. 151+50.

Right-of-way Description

All that portion of the following described rights-of-way (Parcel 1) falling within the west 1/2 of the northeast quarter (W. 1/2, N.E. 1/4) of Section 23, Township 3 North, Range 9 East W.M.

A strip of land 90 ft. in width lying 30 ft. on the right and 60 ft. on the left of the above described centerline from Sta. 136+30 to Sta. 137+50; thence tapering to 110 ft. in width at Sta. 139+00, lying 30 ft. on the right and 80 ft. on the left of the above described centerline; thence 110 ft. in width lying 30 ft. on the right and 80 feet on the left of the above described centerline to Sta. 151+50.

Parcel 2Centerline Description

Beginning at the 1st iron pipe marking the south quarter corner of Section 14, Township 3 North, Range 9 East W.M.; thence S 87° 56' 52" W along the south line of said Section 14, 531.79 feet; thence south 123.90 feet to Engineer's P.C. Station 160+99.88 being the initial point of the centerline herein described, and being the P.C. of a 500 foot radius curve to the right, the long chord of which bears N 51° 17' 14" W; thence following said curve to the right through a central angle of 22° 46' 17" 198.72 ft. to P.O.C. Sta. 162+98.60, said P.O.C. Sta. being the point of intersection of the centerline with the south line of said Section 14 said P.O.C. lying S 87° 56' 52" W 689.98 ft. from the south quarter corner of said Section 14; thence following said curve to the right through a central angle of 3° 50' 40" 33.55 feet; thence N 37° 58' 46" W 267.85 ft. to Engineer's Sta. 166+00. Said point lying N 76° 23' 04" W 901.21 ft. from the south quarter corner of Section 14, Township 3, Range 9 East W.M.
