1. All property which was the separate property of Roy Joseph Schreiber at the time of the execution of the aforesaid Community Property Agreement, together with the rents, issues and profits therefrom, is and shall be the separate property of Roy Joseph Schreiber.

2. All property which was the separate property of Maxine I. Schreiber at the time of the execution of the aforesaid Community Property Agreement, together with the rents, issues and profits therefrom, is and shall be the separate property of Maxine I. Schreiber.

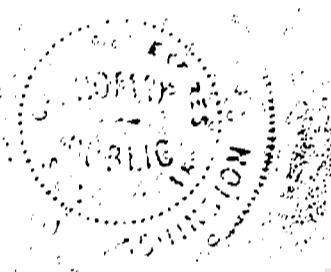
