(1) The purchaser assumes and agrees to pay before delinquency all taxes and assessments that may as between granter and grantee thereafter become a lien on said real estate; and if by the terms of this contract the purchaser has assumed payment of any mortgage, contract or so their encumbrance, or has assumed payment of or agreed to purchase subject to any, taxes or assessments now a lien on said real estate, the purchaser agrees to pay the same before delinquency.

(2) The purchaser agrees, until the purchase price is fully paid to keep the buildings now and hereafter placed on said real estate insured to the actual cash value thereof against closs or damage by both fire and windstorm in a company acceptable to the seller and for the seller's benefit, as his interest may appear, and to pay all premiums therefor and to deliver all policies and renewals thereof to the seller.

In case any partitions are lestate, is taken for public use, the portion of the condemnation award remaining after payment. Of reasonable expenses of procuring the same shall be paid to the seller and applied as payment on the purchase price herein unless the seller elects to allow the purchaser to apply all on a portion of such condemnation award to the rebuilding or restoration of any improvements damaged by such taking. In case of damage or destruction from a peril insered against, the proceeds of such insurance remaining after payment of the reasonable expense of procuring the same shall be devoted to the restoration on the purchase price herein.

(5) The seller has delivered, or agrees to deliver within 15-days of the date of closing, a purchaser's policy of title insurance in standard form, or a commitment therefor, issued by SAFECO Title Insurance Company, insuring the purchaser to the full amount of said purchase price against loss or damage by reason of defect in seller's title to said real estate as of the clate of closing and containing no exceptions other than the following:

a. Printed general exceptions appearing in said policy form;

b. Liens or endumbrances which by the terms of this contract the purchaser is to assume, or as to which the conveyance hereunder is to be made subject; and

Any existing contract or contracts under which seller is purchasing said real estate, and any mortgage or other obligation, which seller by this contract agrees to pay, none of which for the purpose of this paragraph (5) shall be deemed defects in seller's title.

(6) If seller's title to said real estate is subject to an existing contract or contracts under which seller is purchasing said real estate, or any mortgage or other obligation which seller is to pay, seller agrees to make such payments in accordance with the terms thereof, and upon default the purchaser shall have the right to make any payments necessary to remove the default, and any payments so made shall be applied to the payments next falling due the seller under this contract.
