

DEED GRANTING EASEMENT

I, LEE H. SMITH; a married man dealing with my separate property, in consideration of One Dollar (\$1.00), receipt of which is acknowledged, hereby grant, bargain, sell, and convey to RICHARD J. NATHE and PAULA NATHE, husband and wife, a perpetual non-exclusive easement for a domestic water supply line, not to exceed one (1) inch in diameter under, over, through and across the following described property:

Beginning at a point forty chains north and twenty chains west of the southeast corner of Section 25, Township 3 North, Range 7 E.W.M.; thence south eleven chains, thence east two chains; thence south four chains; thence west two chains; thence south ten chains; thence east eight chains; thence north twenty-five chains; thence west eight chains to the place of beginning; TOGETHER with all appurtenances thereunto belonging and SUBJECT however to any road rights of way now established on, over across or affecting the above described real property;

in the location where a water line serving the residence of the said RICHARD J. NATHE and PAULA NATHE, husband and wife, described as:

A tract of land located in the Southeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$ SE $\frac{1}{4}$) of Section 25, Township 3 North, Range 7 E.W.M., described as follows:

Beginning at the SE corner of the said Section 25; thence N 01° 11' 17" West along the E line of said section 990 ft.; thence W 857 ft.; thence S 1,000.98 ft. to intersection with the S line of said Section 25; thence N 89° 13' 40" E 836.63 ft. to the point of beginning;

EXCEPT the 300 foot strip of land acquired by the USA for the BPA's electric power transmission lines; AND SUBJECT to a transmission line easement 87.5 ft. in width granted to the USA by deed recorded at Page 281 of Book 51 of Deeds, records of Skamania County, Washington;

presently exists; together with the right to operate, maintain and repair said water line.
