## AMENDMENT OF REAL ESTATE CONTRACT

This AMENDMENT OF REAL ESTATE CONTRACT executed this date between RICHARD F. WANTLAND and JOSEPHINE WANTLAND, husband and wife, hereinafter referred to as "Seller", and RAY O. GAPPMAYER and MARTHA GAPPMAYER, husband and wife, hereinafter referred to as "Purchaser",

WHEREAS, said seller's (vendor's) interest in said property and contract has been conveyed and assigned to the undersigned RICHARD F. WANTLAND and JOSEPHINE WANTLAND, husband and wife, and the interest of said purchaser in said contract and property has been conveyed and assigned to RAY O. GAPPMAYER and MARTHA GAPPMAYER, husband and wife, and the parties desiring to provide herein for the amendment of the terms of said contract in certain particulars,

SUBJECT TO electric transmission line easement,

any, as now appearing of record.

NOW THEREFORE, in consideration of the mutual agreements herein contained, the parties covenant and agree as follows:

That the terms of the aforesaid real estate contract relating to the purchase price and terms of payment is modified and amended to read as follows:

, That the principal balance remaining unpaid for the sale and purchase of the above described real property as of the date of this instrument is the sum of FIFTEEN THOUSAND SIX HUNDRED FORTY-THREE AND 02/100° DOLLARS (\$15,643.02), with interest thereon paid to April 25, 1983. That such balance of the \* purchase price shall be due and payable by purchaser

to seller in monthly installments of THREE HUNDRED AND NO/100 DOLLARS (\$300.00), or more at purchaser's option, commencing on May 22, 1983, and continuing on the same day of each month thereafter until the entire purchase price and interest is paid in full. The declining principal balances of the purchase price shall bear interest from April 25, 1983, at the rate of ten percent (10%) per annum, and the monthly installments aforesaid shall be first applied to the interest accruing from payment to payment, and the balance credited to the principal.

2. That the aforesaid real estate contract as hereinabove amended and modified shall be and remain in full force and effect.
