Gittens and Richard Kantjas

all of its right, title and interest in the following described real property situated in the County of Skamania, State of Washington, to wit: Lot 1-3 in the Fifth Addition to the Plats of Relocated North Bonneville recorded in Volume B of Plat Records, Pages 51 and 52, Skamania County Auditors File No. 94016. 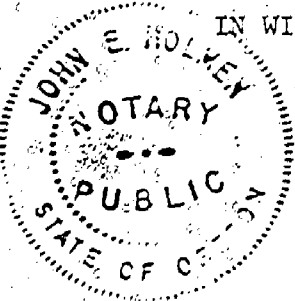
