EXECUTORS' DEED

Deed made May 5, 1983, between SAMUEL J. SEAMAN, of Carson, Skamania County, Washington, and DONNA J. CAREY, of Portland, Multnomah County, Oregon, herein referred to and acting as joint co-executors of the Estate of EARL S. SEAMAN, deceased, and EARL W. SEAMAN of Carson, Skamania County, Washington; ROBERT W. SEAMAN of Carson, Skamania County, Washington; SAMUEL J. SEAMAN of Carson, Skamania County, Washington; and DONNA J. CAREY of Portland, Multnomah County, Oregon, herein referred to as grantees.

The parties recite and declare that:

- 1. On January 21, 1982, Earl S. Seaman executed his will disposing of all of his property. Earl S. Seaman died on August 17, 1982, and his will was duly admitted to probate by proper order of the Superior Court of the County of Skamania, State of Washington.
- 2. By the terms of the will, in Paragraph IX. B., certain residuary property rights and interests were devised to said grantees.
- 3. The will conferred on Samuel J. Seaman and Donna J. Carey, as joint co-executors, general authority to sell and dispose of any portion of the estate and to execute conveyances thereof.
