The terms and conditions of this contract are as follows: The purchase price is SIXTY-FIVE THOUSAND ---

18 65 ,000 .00) Dollars, of which TWENTY-FIVE THOUSAND-----been paid, the receipt whereof is hereby acknowledged, and the balance of said purchase price shall be paid as follows:

FOUR HUNDRED---or more at purchaser's option, on or before the September

and FOUR HUNDRED---

15th or more at purchaser's option, on or before the day of each succeeding calendar month until the balance of said purchase price shall have been fully paid. The purchaser further agrees to pay interest on the diminishing balance of said purchase price at the

race of 17½% per cent per annum from the 15th day of August which interest shall be deducted from each installment payment and the balance of each payment applied in reduction of principal. All payments to be made hereunder shall be made at Rainier National Bank, White Salmon, WA Branch or at such other place as the seller may direct in writing.

The balance of the contract, both principal and interest, shall be paid in full within 10 years from the closing date of this contract.

(1) The purchaser assumes and agrees to pay before delinquency all taxes and assessments that may as between grantor and grantee whereafter become allien on said real estate; and if by the terms of this contract the purchase; has assumed payment of any mortgage, contract or other encumbrance or has assumed payment of or agreed to purchase subject to, any taxes or assessments now a lien on said real estate, the purchaser agrees to pay the same before delinquency.

(2) The purchaser agrees, until the purchase price is fully paid to keep the buildings now, and hereafter placed on said real estate insured to the actual cash value thereof against loss or damage by both fire and windstorman acceptable to the seller and for the seller's benefit, as his interest may appear, and to pay all premiums therefor and to deliver all policies and renewals thereof to the seller.

The purchaser covenants to keep the buildings and other improvements on said real estate in good repair and not to permit waste and not to use, or permit the use of the real estate for any illegal purpose.
