BEGINNING at the North Quarter corner of Section 28, Township 2 North, Range 5 East of the Willamette Meridian; thence along the North-South centerline South 08° 26' 45" East 1,025.00 feet to a point; thence South 89° 43' 23" West 50.00 feet to a pipe at point of beginning; thence North 89° 43' 17" East 266.99 feet; thence South 27" 37' 18" East 746.52 feet to Westerly boundary of LaBarre County Road; thence along road boundary South 45° 18' West 169.78 feet; thence through a curve to the left with a radius of 411.97 feet; through a central angle of 9° 45' a distance of 70.10 feet; thence South 35° 33' West 66:73 feet; thence through a curve to the right with a radius of 351.97 feet through a central angle of 8° 45' a distance of 54.67 feet; leave road and thence North 2° 04' 35" East 411.26 feet to a pipe; thence North 36° 50'04" West 647.20 feet to the point of beginning.
