JERMANN, husband and wife, all its right, title and interest, in and to the following described real property situated in Skamania County, State of Washington:

On easement for highway slopes over that portion of Lot 1, Block 5, of Riverview Addition to the town of Stevenson lying northwesterly of a line drawn parallel with and 38 feet southeasterly of the survey line of SR 14, Stevenson at East City Limits, as conveyed to the State of Washington by deed recorded June 1, 1949 in Volume 32 of Deeds, page 408, records of said county.

The specific details concerning all of which may be found on sheet 1A of that certain plan entitled SR 14, Stevenson at East City Limits, now of record and on file in the office of the Secretary of Transportation at Olympia, Washington, bearing date of approval July 16, 1946.
