Eight Thousand Five Hundred The terms and conditions of this contract are as follows: The purchase price is - (\$ 8 , 500 . 00 ) Dollars, of which ຼຸ ) Dollars have been paid, the receipt whereof is hereby acknowledged, and the balance of said purchase price shall be paid as follows: \_\_ { (\$ 200.00 ) Dollars, Two hundred and no/100-September or more at purchaser's option, on or before the Two Hundred and no/100 day of each succeeding calendar month until the balance of said or more at purchaser's option, on or before the ľOth purchase price shall have been fully paid. The purchaser further agrees to pay interest on the diminishing balance of said purchase price at the rate of zero (0%) per cent per annum from the 10th day of August which interest shall be deducted from each installment payment and the balance of each payment applied in reduction of principal. All payments to be made hereunder shall be made at PO Box 22, Carson Washington 98610 or at such other place as the seller may direct in writing 1983 August As referred to in this contract, "date of closing" shall be

(1) The purchaser assumes and agrees to pay before delinquency all taxes and assessments that may as between grantor and grantee. hereafter, become a lien on said real estate; and if by the sterms of this contract the purchase shas assumed payment of any mortgage, contract or other encumbrance or has assumed payment of or agreed to purchase subject to any taxes or assessments now as lien on said real estate; the purchaser agrees to pay the same before delinquency.

(2) The purchaser agrees, until the purchase price is fully paid, to keep the buildings now and hereafter placed on said real estate insured to the actual cash value thereof against loss for damage by both, fire and windstorm in a company acceptable to the seller and for the seller's benefit, as his interest may appear, and to pay all premiums therefor and to deliverall policies and renewals thereof to the seller.

(3) The purchaser agrees that full inspection of said real estate has been made and that melther the seller nor his assigns shall be held to any covenant respecting the condition of any improvements thereon nor shall the purchaser for seller or the assigns of either be held to any covenant or agreement for alterations improvements or repairs unless the covenant or agreement relied on is contained herein or is in writing and attached to and made a part of this contract.

(4) The purchaser assumes all hazards of damage to or destruction of any improvements now on said real estate or hereafter placed thereon: and of the taking of said real estate or any partithereof for publicuse; and agrees that no such damage destruction or taking shall constitute a vfailure of consideration. In case any part of said real estate, is taken for public use, the portion of the condemnation award remaining after applied as payment on the purchase price herein unless the seller telects to allow the purchaser to apply all or a portion of such condemnation award to the rebuilding or restoration of any improvements sydamaged by such traking in case of damage or destruction from a perilinsured against, the proceeds of such insurance remaining after payment vofethe reasonable expense of procuring the same shall be devoted to the restoration or rebuilding of such improvements within a reasonable time, unless purchaser elects that said proceeds shall be paid to the seller for application on the purchase price herein.

(5) The seller has delivered or agrees to deliver within 15 days of the date of closing a purchaser's policy of title insurance in standard form, or a commitment therefor, issued by SAFECO Title insurance Company, insuring the purchaser to the full amount of said purchase price against loss or damage by reason of defect in seller's title to said real estate as of the date of closing and containing no exceptions other than the following:

a. Printed general exceptions appearing in said policy form;

b. Liens or encumbrances which by the terms of this contract the purchaser is to assume, or as to which the conveyance hereunder is to be

Any existing contract or contracts under which seller is purchasing said real estate, and any mortgage or other obligation, which seller by this contract agrees to pay, none of which for the purpose of this paragraph (5) shall be deemed defects in seller stitle.

(6) If seller's title to said real estate is subject to an existing contract or contracts under which seller is purchasing said real estate; or any mortgage or other obligation which seller is to pay, seller agrees to make such payments in accordance with the terms thereof, and upon default, the purchaser shall have the right to make any payments necessary to remove the default, and any payments so made shall be applied to the payments next falling due the seller under this contract.
