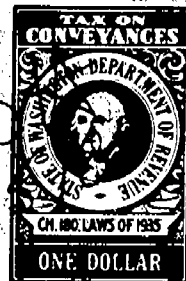
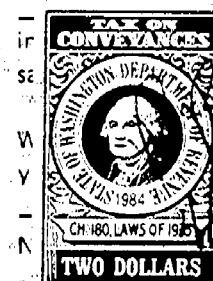

The East half of the Northeast quarter of Section 25, Township 2 North, Range 5 East of the Willamette Meridian.

The Northwest quarter of the Northwest quarter of the Northeast quarter of Section 35, Township 2 North, Range 5 East of the Willamette Meridian.
