Taxes and Liens

3.1 Payment. Borrower shall pay when due all taxes and assessments against the Mortgaged Property and all claims and demands arising from Borrower's use or occupancy of the Mortgaged Property. Borrower shall pay when due before they become delinquent, all taxes and assessments levied against or on account of the Mortgaged Property, and shall pay when due all claims for work done on or for services rendered or material furnished to the Mortgaged

3.2 Protection of the Mortgaged Property. Borrower shall not permit any lien prior or equal to the lien of this Mortgage to be imposed upon the Mortgaged Property, except for the lien of taxes and assessments not due, except for the prior indebtedness referred to in Section 12 and except as otherwise

provided in Section 3.3.

3.3 Borrower's Right To Contest. Borrower may withhold payment of any taxes, assessments, claims, or demands, or may elect to contest any lien if Borrower is in good faith conducting appropriate proceedings to contest the obligation to pay and so long as Lender's interest in the Mortgaged Property is not jeopardized. If the Mortgaged Property is subject to a lien which is not discharged within 15 days after the lien arises or, if a lien is filed, within 15 days after Borrower has notice of the filing. Borrower shall deposit with Lender cash, a sufficient corporate surety bond, or other security satisfactory to Lender in an amount adequate to provide for the discharge of the lien plus any interest, costs, or attorneys, fees or other charges that could accrue as a result of foreclosure or sale. 3.5. Tax Reserves. 4.3 Compliance with Laws, Borrower warrants that its use of the Mortgaged Property complies with all existing applicable laws, ordinances, and regulations of governmental authorities.

6.1 State Taxes Covered. This section shall apply to the following state taxes:

A specific tax on mortgages or any part of the indebtedness secured by a mortgage or security agreement. A specific tax on the owner of mortgaged property which the taxpayer is authorized or required to deduct from payments on the mortgage.

A tax on mortgaged property chargeable against the mortgagee or holder of the note secured by the mortgage

If Borrower is a corporation, "transfer" also includes any change in ownership of more than 25 percent of the voting stock of Borrower.
