

QUIT CLAIM DEED

THE GRANTOR, DAVID G. LARIVE, for and in consideration of THREE THOUSAND and no 100 DOLLARS (\$3,000.00), does hereby convey and quit claim to ELEANOR SZYDLO, a widow woman, grantee, the following described real estate, situated in the County of Skamania, State of Washington, together with all after acquired title, to-wit:

All that portion of the following described real property lying adjacent to property owned by the Grantee, and northerly of the center of the Burlington Northern Railroad easement, and easterly of Sweeney Road:

A tract of land located in Government Lot 5 of Section 31, Township 3 North, Range 8 East, W.M., more particularly described as follows: Beginning at a point which is 1,800 feet south of quarter corner between sections 30 and 31, Township 3 North, Range 8 East, W.M.; thence following the meanderings of the county road as the same was laid out and established on October .1, 1909, to a point 1,007 feet distant from the north 55 degrees, 30 minutes east of the point of beginning; thence south 799 feet to a point on a rock ledge (witness an iron stake near a fir tree 2 feet in diameter north 40 degrees west 3 feet distant); thence south 60 degrees, 30 minutes west 370 feet along the edge of the rock ledge; thence south 300 feet; thence south 75 degrees, 30 minutes west 520 feet; thence north 840 feet to the point of beginning; SUBJECT to exceptions, easements and rights-of-way of record. 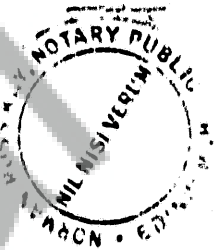
