## DEED OF PERSONAL REPRESENTATIVE

THE GRANTORS, ALBERT C. ANGELO, LEWIS ANGELO, MARY D. ANGELO BAILEY and TED ANGELO, each individually and as the personal representatives of the joint estates of SAM ANGELO and JULIA DI ANGELO, deceased, in distributing the assets of said joint estates, convey and quit claim to ALBERT C. ANGELO, LEWIS ANGELO, MARY D. ANGELO BAILEY and TED ANGELO, in undivided one-fourth interests, the following described real estate situated in Skamania County, Washington, to-wit:

PARCEL #1 Lot 7 of Stevenson Park Addition to the Town of Stevenson, according to the official plat thereof on file and of record in the office of the Auditor of Skamania County, State of Washington, excepting the east two acres thereof, but conveying easement along the southerly twenty feet of said excepted tract for road purposes.

PARCEL #2 Commencing at the quarter corner on the west line of Section 3, Township 1 N, R 5 E.W.M.; thence N 87 degrees, 50 minutes E 22.88 chains to the west boundary of 60 foot road; thence S 1 degree, 46 minutes W along the west boundary of county road 9.06 chains to the northeast corner of McPhersons tract; thence W 7.82 chains along the north line of said tract to the northwest corner of said tract; thence S along the west line of said tract 3.23 chains; thence W 14.76 chains to the west line of quarter section; thence N to the place of beginning, containing 24.35 acres, more or less,

INCLUDING all easements, water rights, or other rights and privileges appurtenant thereto or used in connection therewith, and particularly the water right and pipeline used in connection therewith.

PARCEL #3 The West Half (W $\frac{1}{2}$ ) of fractional Northwest Quarter (NW $\frac{1}{4}$ ) of Section 3, Township 1 North, Range 5 E.W.M., containing 80 acres, more or less, all lying and being in the County of Skamania, State of Washington.

PARCEL #4 The East twenty-five (25) acres of the Southeast Quarter of the Northeast Quarter (SE $\frac{1}{4}$ NE $\frac{1}{4}$ ) of Section 4, Township

ANGELO BAILEY, and TED ANGELO, were confirmed as personal representatives of the joint estates on November 12, 1985, and ever since have been and are now the duly appointed, qualified and acting personal representatives thereof. This deed is made pursuant to an Order of Solvency entered In The Matter of The Estates of SAM ANGELO and JULIA DI ANGELO, Deceased, being Probate Cause No. 85-4-00015-2, in the Superior Court of Skamania

County, Washington, on November 12, 1985.
