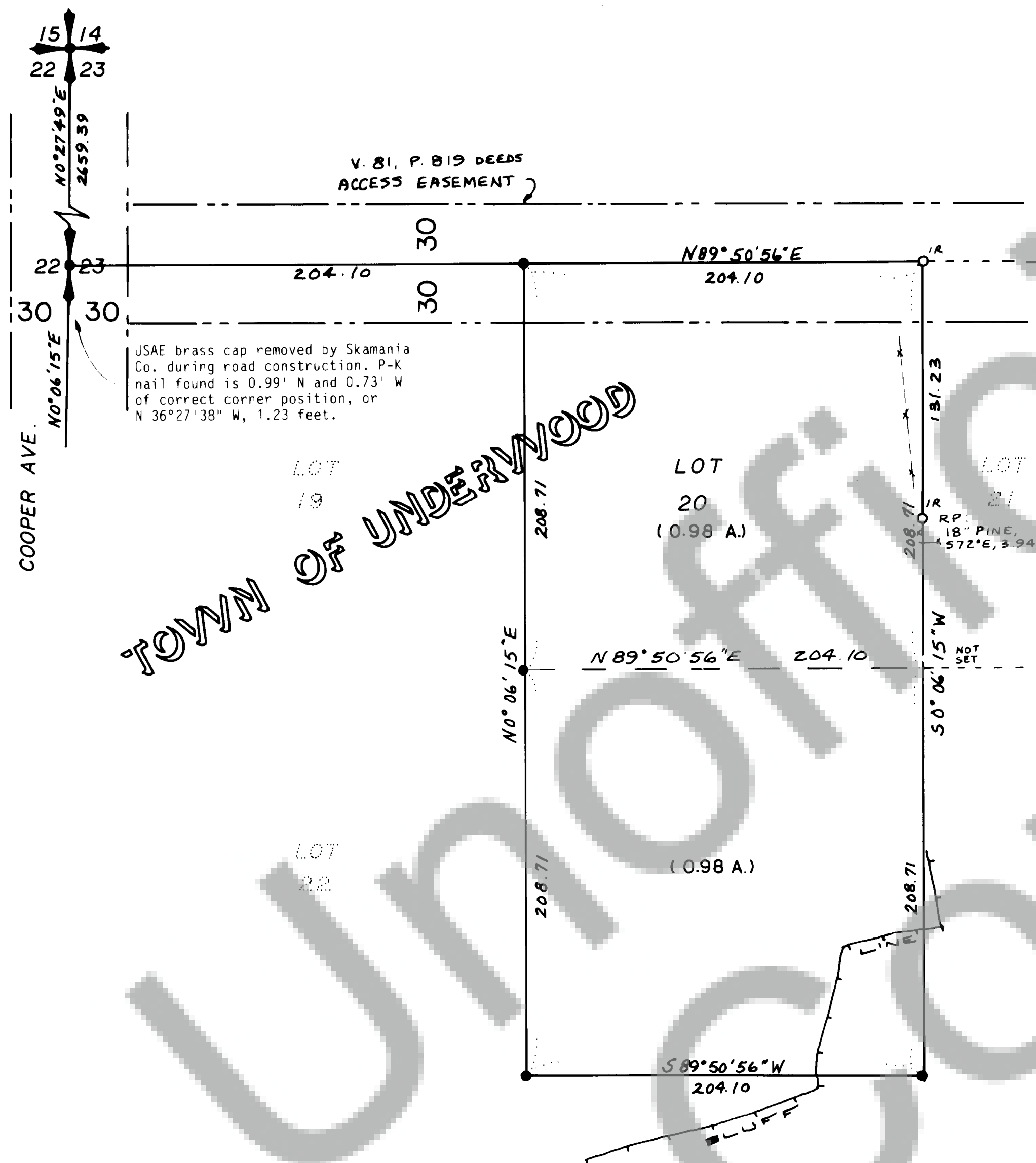


SURVEY IN NW 1/4 SW 1/4 SEC. 23, T.3N, R.10E, W.M.

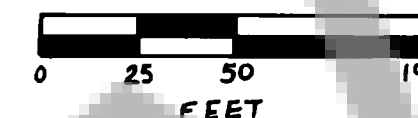
DESCRIPTION:

Lot 20 of the Town of Underwood, within the NW 1/4 SW 1/4 of Section 23, T3N, R10E, W.M., as shown on the map thereof recorded in Book "A" of Plats at Page 14; PLUS the following parcel, described as:  
Beginning at the southwest corner of said Lot 20, which is an iron rod; thence N 89°50'56" E, 204.10 feet along the south boundary thereof to the southeast corner of said Lot; thence on a southerly extension of the east line of said Lot 20, S 00°06'15" W, 208.71 feet; thence parallel with the south line of said Lot 20, S 89°50'56" W, 204.10 feet; thence N 00°06'15" E, 208.71 feet to the Point of Beginning.

BASIS OF BEARINGS: Reference 4, taken from the Bonneville Lands Map of 1936, and assumed as true.



- Set 5/8"x30" iron rod with plastic cap
- Found corner of record
- (100) Record call

TRAVERSE STATEMENT: A closed loop traverse was made during the period April 19-26, 1990 using a Pentax PX10D total station last calibrated during June, 1989. An angular error of 15" (2.5"/setup) and a distance error of 0.04 ft./888.58 ft. were balanced by compass adjustment for a calculated error of closure in excess of 1:10000.

NARRATIVE: Available control from Ref. 4 was enlarged to encompass this parcel. The south half of the west line of the entire parcel was flagged and, other than a random fence line as noted, no encroachments were noted.

The parcels and descriptions herein constitute a boundary line adjustment between the adjoining property of the grantor and grantee, and is exempt from the requirements of RCW 58.17 and the Skamania County Short Plat Ordinance. The herein described property cannot be segregated and sold without first conforming to the State of Washington and Skamania County Subdivision laws.
