AN ORDINANCE OF THE CITY OF STEVENSON VACATING A PORTION OF MALLICOTT ROAD AND RESERVING AN EASEMENT FOR UTILITIES AND A PEDESTRIAN AND BICYCLE PATH

Recitals

1. A petition is on file with the City of Stevenson to vacate that portion of Mallicott Road described as follows:

M.P. 0.35 to 0.56 of Mallicott Road, a distance of .21 miles, said road being located in Section 2, Township 2 North, Range 7 E.W.M., Skamania County, Washington.

- 2. Public hearings have been held by the City Council on November 21, 1991 and December 19, 1991 following public notice pursuant to Chapter 35.79 RCW; and
- 3. Said vacation appears to be of benefit to and in the interest of the public provided that an easement is reserved for utilities and a pedestrian and bicycle path.

Now, therefore, the City Council of the City of Stevenson do ordain as follows:

Section 1. Vacation. Subject to the terms and conditions of this Ordinance, the following described portion of Mallicott Road is hereby vacated:

M.P. 0.35 to 0.56 of Mallicott Road, a distance of .21 miles, said road being located in Section 2, Township 2 North, Range 7 E.W.M., Skamania County, Washington.

Section 2. Easement Reserved. Pursuant to RCW 35.79.030, the GS of Stevenson hereby retains a perpetual easement over the vacated portion of Mallicott Road for the construction, repair and maintenance of public utilities and for a public pedestrian and bicycle path.

Section 3. Quit Claim Deed. Upon compliance with the terms and conditions of this Ordinance, the owner of abutting property entitled to the vacated portion of Mallicott Road, pursuant to RCW 35.79.040, may present a quit claim deed to the City of Stevenson for execution by the Mayor, who is hereby authorized and directed

to execute such quit claim deed. Such quit claim deed shall include all reservations, conditions, or other qualifications upon the title established by this Ordinance.

Section 4. Effective Date. This Ordinance shall be effective only upon the satisfaction of the terms and conditions of this Ordinance, and the Clerk is hereby directed to file, record and publish this Ordinance upon that satisfaction.


