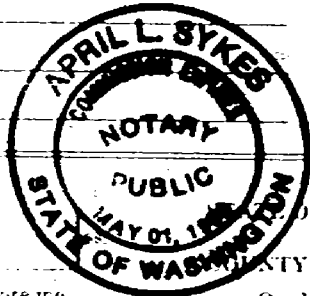

A Tract of land in the Southeast Quarter of Section 36, Township 4 North, Range 7 1/2, East of the Willamette Meridian, in the County of Skamania, State of Washington, described as follows:

Lot 2 of the LLOYD LOUTHER SHORT PLAT, recorded in Book 3 of Short Plats, Page 216, Skamania County Deed Records.

1. Rights of the Public in and to that portion lying within road.
2. Easement for utilities including the terms and provisions thereof recorded April 27, 1915 in Book "P", Page 249, Skamania County Deed Records. Also recorded April 27, 1915 in Book "P", Page 252, Skamania County Deed Records.
3. Rights of others thereto entitled in and to the continued uninterrupted flow of Panther Creek, and rights of upper and lower riparian owners in and to the use of the waters and the natural flow thereof.
4. Any adverse claims based upon the assertion that Panther Creek has moved.
5. Easement for roads as shown on the recorded Plats.
6. Agreement creating mutual easement for Common driveway including the terms and provisions thereof recorded June 3, 1988 in Book 109, Page 697, Skamania County Deed Records.
