Subordination Agreement

NOTICE: THIS SUBORDINATION AGREEMENT RESULTS IN YOUR SECURITY INTEREST IN THE PROPERTY BECOMING SUBJECT TO AND OF LOWER PRIORITY THAN THE LIEN OF SOME OTHER OR LATER SECURITY INSTRUMENT.

The undersigned subordinator and owner agrees as follows: PACIFIC FIRST BANK referred to herein as "subordinator", is the owner and holder of a mortgage dated ... DECEMBER 17, ... 1990 which is recorded in volume 126 of Mortgages, page 581, under auditor's file No. 112621, records of SKAMANIA County. RIVERVIEW SAVINGS BANK, a Washington Comporation . referred to herein as "lender", is the Skamania County) (which is to be recorded concurrently herewith). ERNEST ALLEN TIFFANY & SHARON LEE TIFFANY referred to herein as "owner", is the owner of all the real property described in the mortgage identified above in Paragraph 2. In consideration of benefits to "subordinator" from "owner", receipt and sufficiency of which is hereby acknowledged, and to induce "lender" to advance funds under its mortgage and all agreements in connection therewith, the "subordinator" does hereby unconditionally subordinate the lien of his mortgage identified in Paragraph 1 above to the lien of "lender's" mortgage, identified in Paragraph 2 above, and all advances or charges made or accruing thereunder, including any extension or renewal thereof.
