RESIGNATION AND APPOINTMENT OF SUCCESSOR TRUSTEE CARL HOLLISTON

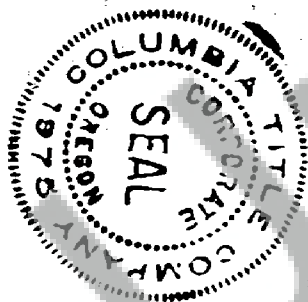
KNOW ALL MEN BY THESE PRESENTS:

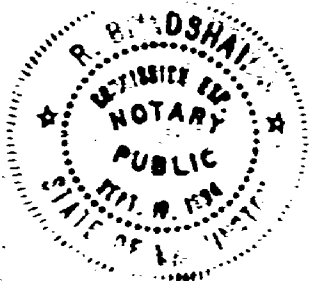
