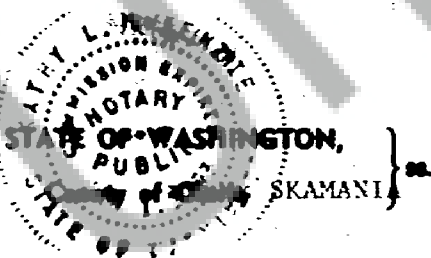

Exhibit A

That portion of the Southeast quarter of the Southeast quarter of Section 26, Township 2 North, Range 6 East of the Willamette Meridian, Skamania County, Washington, described as follows:

BEGINNING at a point 859.4 feet North and 30 feet East of the Southwest corner of the Southeast quarter of the Southeast quarter of the said Section 26; thence South 286.4 feet; thence East 50 feet; thence South 30 feet; thence East 261.5 feet, more or less, to a point 543 feet North and 311.5 feet East of the Southwest corner of the Southeast quarter of the Southeast quarter of said Section 26; thence North  $17^{\circ}47'$  West 401.5 feet to a point on the South line of Little Street North  $70^{\circ}46'$  East 200 feet from the point of beginning; thence South  $70^{\circ}46'$  West 200 feet to the point of beginning.

EXCEPT that portion thereof conveyed to G.W. Willson and wife by deed dated September 6, 1945, and recorded September 12, 1945, at page 480 of Book of 30 of Deeds, Records of Skamania County, Washington.

Also the following described property:

BEGINNING at a point 543 feet North and 311.5 feet East of the Southwest corner of the Southeast quarter of the Southeast quarter of said Section 26; thence East 75 feet to the West boundary of the road formerly designated as State Highway No. 8; thence Southerly along the West boundary of said road to intersection with the Northerly right of way line of Primary State Highway No. 8 as presently established; thence Southwesterly following the Northerly right of way line of said highway 200 feet, more or less, to a point South  $07^{\circ}30'$  East from the point of beginning; thence Southwesterly along the Northerly right of way of said highway 100 feet; thence North  $07^{\circ}30'$  West 400 feet, more or less, to intersection with the South line of the tract of land first above described; thence East to the point of beginning.
