

(FULFILLMENT) Statutory Warranty Deed

THE GRANTOR ROSER E. MORTENSON, an unmarried man as to an undivided one-half interest, and PENNY K. MORTENSON, an unmarried woman as to an undivided one-half interest, the parties formerly acquired title as "husband and wife" for and in consideration of "FULFILLMENT OF THE REAL ESTATE CONTRACT BALANCE"

in hand paid, conveys and warrants to ROYAL E. KIELING and GAYLE E. KIELING, husband and wife the following described real estate, situated in the County of Skamania, State of Washington:

A tract of last in the Bortheset general of section 17, rowship 1 Borth, Range 3 last of the Williamste Burillan, is the County of Skamania, State of Washington, described as follows:

Beginning at a point 436 feet morth of the Morthoust corner of the Southeast quarter of the Morthoust quarter of said Section 17; thence Morth 561 feet; thence East 506 feet; thence South 563 feet; thence West 506 feet to the point of beginning.
