To protect the security of this Deed of Trust. Grantor covenants and agrees:

- 1. To keep the property in good condition and repair; to permit no waste thereof; to complete any building, structure or improvement being built or about to be built thereon; to restore promptly any building, structure or improvement thereon which may be damaged or destroyed; and to comply with all laws, ordinances, regulations, coverants, conditions and restrictions affecting the property.
- 2. To pay before delinquentall lawful taxes and assessments upon the property, to keep the property free and clear of all other charges, hens or encumbrances impairing the security of this Deed of Trust.
- 3. To keep all hulldings now or hereafter erected on the property described herein continuously insured against loss by fire or other hazards in an amount not less than the total debt secured by this Deed of Trust. In the event of foreclosure, all rights of the Grantor in insurance policies then in force shall pass to the purchaser at the foreclosure sale.
