A tract of land located in the Southeast Quarter of the Northeast Quarter of Section 22, Township 3 North, Range 10 East of the Willamette Meridian, in the County of Skamania, State of Washington described as follows:

Beginning at a point South  $89^{\circ} 33'$  West 974.81 feet from the Quarter corner common to Sections 22 and 23, Township 3 North, Range 10 East of the Willamette Meridian; thence South  $89^{\circ} 33'$  West 56.32 feet; thence North  $00^{\circ} 29'$  East 19 feet to the True Point of Beginning of the tract hereby described; thence North  $00^{\circ} 20'$  East 252 feet; thence South  $84^{\circ} 18'$  East 167.42 feet; thence South  $29^{\circ} 50'$  East 87 feet; thence South  $09^{\circ} 25'$  East 43 feet; thence South  $50^{\circ} 08'$  West 182.56 feet; thence South  $89^{\circ} 33'$  West 79.07 feet to the True Point of beginning.

EXCEPTING therefrom the following:

Beginning at a point South  $89^{\circ} 33'$  West 974.81 feet from the Quarter corner of the East line of the said Section 22; thence South  $89^{\circ} 33'$  West 56.32 feet; thence North  $00^{\circ} 29'$  East 19 feet to the initial point of the tract hereby described; thence North  $89^{\circ} 33'$  East 45 feet; thence Northwesterly in a straight line to a point which is North  $00^{\circ} 29'$  East 252 feet from the initial point; thence South  $00^{\circ} 29'$  West 252 feet to the initial point.
