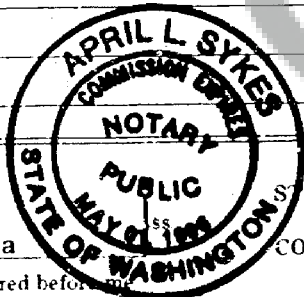

Beginning at the Northeast corner of the Southwest Quarter of the Northeast Quarter of said Section 34; thence South on subdivision line 660 feet; thence West 288 feet to the initial point of the tract hereby described; thence West 22 feet, more or less, to the count road known and designated as the Skelton Cut Off Road; thence Southerly along said Skelton Cut Off Road to intersection thereof with the Northerly line of Primary State Highway No. 8; thence Easterly along the Northerly line of Primary State Highway No. 8 a distance of 280 feet; thence in a straight line in a Northerly direction 406 feet to the initial point.
