THE GRANTOR, the UNITED STATES OF AMERICA, acting by and through the SECRETARY OF THE ARMY, under and by virtue of the authority vested in him by the provisions of Section 2 of the Act of Congress, approved 20 June 1938 (52 Stat. 804; 33 U.S.C. 558b) as amended by the Act of Congress approved 11 August 1939 (53 Stat. 1414; 33 U.S.C. 558b-1) and Section 83 of the Act of Congress approved 7 March 1974 (Public Law 93-251; 38 Stat. 35); and in partial satisfaction of the obligations of the Government imposed by Relocation Contract No. DACW57-76-C-0039, dated 19 August 1975, on record in the office of the District Engineer, U.S. Army Engineer District, Portland, Oregon, 319 Southwest Pine Street, Portland, Oregon 97204, hereby grants to the CITY OF NORTH BONNEVILLE, a municipal corporation of the State of Washington, its successors and assigns, a perpetual easement for right-of-way for an underground sewer outfall line under and across the land described in Schedule "A" attached hereto and made a part hereof, together with the right to enter upon said land for the maintenance and repair of said sewer outfall line.

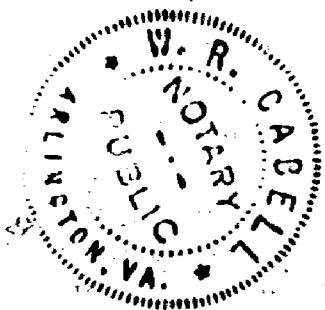

Easement for Sewer Outfall Line

Description:

A strip of land 30 feet in width, being 15 feet on each side of a centerline extending from the new sewage treatment plant to the Columbia River, lying in Section 29, Township 2 North, Range 7 East of the Willamette Meridian, Skamania County, Washington. The centerline referred to above being more particularly described as follows:

BEGINNING at Station 0 + 00 of the sewer outfall line, said point lying North $56^{\circ}32'19''$ West 226.05 feet from monument N. NB-13 at the southeast corner of the sewage treatment plant (Lot M-20);

thence South $29^{\circ}00'$ East 1,382.00 feet to Station 13 + 82 and the point of terminus of the above described centerline.

There is EXCEPTED therefrom all that portion lying in Lot M-20 of the City of North Bonneville, Washington.

The strip of land above described contains 0.84 of an acre, more or less.
