Beginning at the Southwest corner of the Southeast quarter of Section 17, Township 3 North, Range 8 East of the Willamette Meridian; thence North 30 feet; thence East 30 feet; thence North 686.8 feet; thence North 89° 15' East 634.5 feet; thence North 1,373.6 feet; thence North 89° 15' East 634.5 feet to the initial point of the tract hereby described; thence North 592.5 feet to a point on the center line running East and West through the said Section 17; thence along said center line North 89° 55' West to intersection with the Easterly line of the 150 foot right of way granted to the State of Washington for State Secondary Highway No. 8-C by deed dated October 20, 1956, and recorded at Page 499 of Book 42 of Deeds, Records of Skamania County, Washington; thence in a Southeasterly direction following the Easterly line of said 150 foot right of way to a point South 89° 15' West from the initial point; thence North 89° 15' East to the initial point;
