HUESTIS and TYRA HUESTIS, husband and wife, their heirs, personal representatives, successors and assigns, a perpetual, nonexclusive easement for ingress, egress and utilities over, under, through and across the south 20 feet of the following described real estate situated within Skamania County, State of Washington, legally described as follows:

A portion of the Northeast Quarter of the Northeast Quarter of Section 34, Township 2 North, Range 5 East of the Willamette Meridian, Skamania County, Washington, described as follows:
